

### Background

Pre-exposure prophylaxis (PrEP) is the use of antiretrovirals in people who are HIV negative before a possible exposure to HIV. Multiple products are recommended by WHO as PrEP for people at risk of HIV, all of which are safe and effective. These products include oral TDF-based PrEP, injectable long-acting cabotegravir (CAB-LA), and the dapivirine vaginal ring (DVR). PrEP can play a crucial role in protecting adolescents and young people against HIV acquisition, as part of combination prevention approaches.

Adolescence is a unique developmental stage, and this developmental stage might affect service delivery and issues including adherence and retention in care. Despite these challenges, evidence and programmatic experience shows that adolescents can successfully take PrEP.

This webinar would help to EDUCATE and understand key learning and information on PrEP to increase knowledge about PrEP, EXPLORE best practices, models and actions that could serve as learning points while also mitigating barriers and ENHANCING solutions to accessing PrEP.
