Measuring and monitoring **the Key Population programme** outputs and outcomes **at national and global level**



270 participants attended representing +40 countries.

Recap of the webinar agenda

In unpacking the global targets in relation to the KP programme and possible approaches to measuring outputs and outcomes, **Keith Sabin (UNAIDS)** reminded us of the ***2030 global HIV Key Population targets and current estimations***, highlighting the challenges faced and what is needed to achieve the goal.

Amrita Roa and **Kate Rucinski (JHU)** outlined how ***routine data can be used to answer programme-relevant questions***. They took us through country examples of how this has been done for FSW, MSM and AGYW.

We heard from country representatives on ***practical approaches to implementing monitoring an evaluation systems to monitor KP programme progress***:

In the morning session:

- **Keshab Deuba** and **Neet Sedhain (Nepal MOH)** reflected on the DHIS2 tracker-based information system used in Nepal for evaluating their HIV programme using real-time evidence from health facility level to provincial and federal level.
- **Peter Mudioppe (Uganda MOH)** presented on the development of biological and behavioural surveillance (BBS) Lite - a simplified survey method for HIV, viral hepatitis and STI surveillance among Key Populations in Uganda.

In the afternoon session:

- **Jebet Boit (Kenya MOH)** provided an overview of Kenya's routine KP programme monitoring activities and systems, highlighting the use of the One National Reporting System
- **Ketevan Stvilia and colleagues (Georgia MOH)** presented on piloting of BBS-Lite among PWID in Georgia which ran from 2021-2022.

KP-led organisations also shared their successful efforts and practices in running **community-led monitoring (CLM) processes**:

- **Shahnaz Islamova** is the director of the Tais Plus NGO, Kyrgyzstan. Tais Plus is a community-led organisation created and run by sex workers.
- **Viet Trinh** from Light House, in Vietnam, uses a Consumer Advisory Board (CAB) model for client feedback.
- **Aniedi Akpan** from Drug Harm Reduction Advocacy Network (DHARN) in Nigeria reflected on the use of CLM as part of their needle and syringe programme for PWID.

Our sessions were facilitated by **Tim Sladden (UNFPA)** and **Clemens Benedikt (UNAIDS)** who thanked participants for showcasing different aspects of surveillance and monitoring, and highlighted the relevance of the data and measurement tools in Global Fund processes to support the prioritization KP investments.

"I would like to emphasize the trust and data ownership when studies are implemented by community-based organisations..

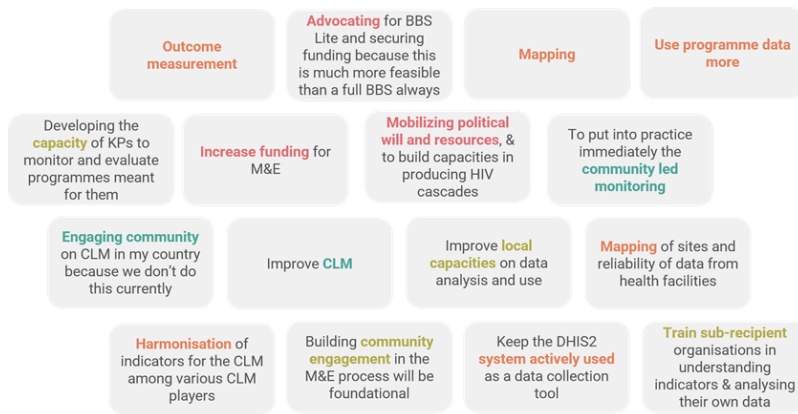
They are also learning how to use research data to modify services" – **Ketevan Stvilia**, MOH (Georgia)
